Hazel Crest Economic Development Commission - Making Big \$ Plans

"The money people, investors and citizens are all at the table. This economic development plan can happen."

Saturday, November 1st was a dreary day, when Hazel Crest stakeholders could have been doing almost anything else. Instead, a group of difference-makers gathered in a basement conference room at Advocate South Suburban Hospital to discuss the economic future of Hazel Crest.

Convened by Village President Vernard L.

Alsberry, Jr. and E. Lamar Rogers, chair of the village Economic Development Commission; the meeting was led by Lakeshia Wright of the South Suburban Mayors and Managers Association (SSMMA). Those participating included Priscilla Cordero, director of the Governors State University Small Business Development Center; and Russell Rydin, executive director, of the South Suburban Land Bank and Development Authority.

Also represented were several local banks, elected officials, small business entrepreneurs, the local VFW, as well as representatives of Mi-Jack and Advocate South Suburban Hospital, the two largest businesses and employers in Hazel Crest.

The goal? To revisit the village's last two comprehensive economic development plans, neither of which have been implemented to any great degree. The spirit around the room seemed to be **now or never**.

The specific charge is to revitalize the area surrounding **Hazel Crest Proper**, the oldest section of the village, also the site of the Metra stop. It is also where the greatest number of residents and non-residents intersect.

During his remarks, **President Alsberry said**, "We have HUD dollars and TIF money over there. If we can't pull this comprehensive plan together, we're all to blame."

The process? During the first half of the economic summit the group divided into six groups, each of which was charged with developing an honest assessment of the strengths and weaknesses of **Hazel Crest Proper**. Each group then delivered their findings.

The consensus of the group was that access to transportation, and revitalizing the area around the **Metra station** was the top economic priority. Modernizing the Metra facility, coupled with business development in the area, was on everyone's list of priorities.

The goal is to improve economic opportunity for residents, as well as capture some of the dollars from non-residents who are just passing through. It is also hoped that the right mix of **restaurants**, **banks**, **gift shops**, **coffee shops**, **grocery outlets**, **dry cleaners**, **office supply stores**, **residences**, and other amenities will make **Hazel Crest Proper**, a go-to destination for residents and non-residents alike.

Other strengths included: the people of Hazel Crest, TIFS, schools, village's rich history, diversity, Veterans Park, and land availability.

Weaknesses noted were similar to those found in most urban and many suburban communities. Perceptions about crime/safety, drugs, economic blight, curb appeal, and lack of services.

It is noted that improving the economic vitality of **Hazel Crest Proper** will serve to alleviate many of the weaknesses, that were expressed during the meeting. It was also suggested that there must be an investment in upgrading the skills of local youth to make them more viable in the current job market.

However, one weakness, the fact that **I/80** separates **Hazel Crest Proper** from the rest of **Hazel Crest**, is just a reality that economic revitalization will not be able to correct.



The second half of the meeting focused on other suggestions for improvement. Those included: using billboards along I/80 to attract businesses; update lighting in Hazel Crest Proper; improve aesthetics around Metra station; give grants to local artists to create positive images of the village; develop a business district/downtown area; 24-hour diner; chain stores and others.

There was also a recommendation to develop a **Fire/Police** satellite at the site of the old fire station. Development of a **community/youth center** was important to give youth other outlets.

All good suggestions. The question now is how to prioritize?

In closing **Lakeshia Wright** noted, "SSMMA represents 43 communities. The more people realize that they have similar problems, the more we can do grants to address those issues."

Hazel Crest President Alsberry said, "Many of

the visions are similar, which means we can make this happen. From here we will move forward."

Chair E. Lamar Rogers reminds readers that, The **Economic Development Commission** meets the **2**nd **Thursday** of each month at the **Fire Station located at** 2903 W 175th ST. at 7PM

Other members of the commission include: Vice Chair Marlon Rias, Rosalyn Owens, Emir Hardy and Art Fykes.

November is National Diabetes Month

Diabetes Awareness Month

As we enter the holiday season, now is a good time to take stock of you

and your family's health. While there are some aspects of **Diabetes** that are beyond your control; you can watch what you eat. But first let's talk about what we're dealing with.

What is Diabetes?

Diabetes results when blood glucose, or sugar, levels are above normal. When your body either doesn't make enough **insulin**, or for some reason can't use its own insulin, sugar builds up in your blood.

About **90 to 95 percent of** adult-onset diabetes, also called non-insulin-dependent diabetes mellitus, results in what is commonly known as **Type 2 Diabetes.** This type of Diabetes can often be prevented or delayed by implementing simple commonsense lifestyle changes.

The Centers for Disease Control (CDC)

reports that Diabetes affects 26 million Americans, 19 million diagnosed and about 7 million undiagnosed. An estimated 79 million American adults 20 years and older have prediabetes, putting them in the highrisk category for developing the disease.

Risk Factors for Type 2 Diabetes

The **CDC** further reports the following risk factors:

- * 45 years or older
- * Overweight
- * Family History
- * Physically active less than 3 times weekly
- * Ever gave birth to a baby weighing more than 9 lbs.
- * Ever had Diabetes while pregnant (gestational diabetes)

Type 2 Diabetes is especially associated with obesity.

Eat Less

- * Limit fat meat & fried foods
- * Cut whole milk & dairy products made from whole milk
- * Limit cakes, candy, cookies, crackers and pies
- * Avoid salad dressings, lard, shortening, stick margarine & non-dairy creamers
- * Limit fruit-flavored drinks, sodas, tea and coffee with sugar
- * Lower salt intake and when cooking, including canned & packaged soups

Eat Better

- * Breakfast cereals with 100 percent whole grains
- * Oatmeal
- * Whole grain rice
- * Whole wheat bread, bagels, pita bread and tortillas

Writers & Editorial Guidelines

- 1. Keep to the 250 1,000 word limit. Get copy in on time.
- 2. Check copy for grammar and spelling before submitting.
- 3. Know what you want to say and say it.
- 4. Write as concisely as possible.
- 5. Substitute small words for large ones whenever possible.
- 6. Use words and phrases that your audience is likely to understand.
- 7. Don't be unnecessarily redundant. Don't use different words to convey the same thoughts.
- 8. Don't use jargon that only those who do similar work understand.
- 9. Write as if you were having a conversation with your audience.
- 10. Don't talk down to your audience.
- 11. Be accurate as to names, titles, degrees and addresses (where relevant).
- 12. Write with passion, not anger.
- 13. Make sure your information is accurate.
- 14. Don't curse, defame, disparage, or violate anyone's privacy.
- 15. Don't write anything that you will regret, if it is published.
- 16. Separate your personal opinions from what is factual.
- 17. Be specific about your information sources.
- 18. Humor doesn't always work. Satire doesn't always work.
- 19. If someone tells you something confidential, maintain their trust.
- 20. Remember that you are writing to either inform, educate or inspire people to do or not do something.
- 21. Use pictures that help support the story.
- 22. Include captions with pictures to help tell the who, when, where, what, why and why story is important.
